# Animal Vaccine Shortages: OBP

# Campaign Report



13 March 2023 - 30 June 2023



# INTRODUCTION

DearSA embarked on a concern raised by citizens of South Africa peaked by shortfall supplies of animal vaccines by Onderstepoort Biological Products (OBP). This data report provides a comprehensive overview of the DearSA campaign's efforts in combating animal vaccine shortages in South Africa. It highlights the background of the issue, the objectives of the campaign, key stakeholders involved, and the impact of the campaign on addressing the shortage.

#### Background:

Civil society has extensively researched the processes and highlights the role of Onderstepoort Biological Products (OBP), a state-owned entity responsible for animal vaccine production. This campaign content mentions the dismissal of OBP's former CEO, Dr Andile Dyasi, due to misconduct and poor governance. Further to this, the current shortage is attributed to Eskom's power supply issues affecting OBP's vaccine production capacity.

#### **Objectives:**

The report outlines the primary objectives of the DearSA campaign, which include:

- Raising awareness about the consequences of animal vaccine shortages on the food chain, disease control, and animal welfare.
- Mobilizing public support and engagement to advocate for a reliable and adequate supply of animal vaccines.
- Collaborating with civil society groups, in particular, SAAI and political group, the Democratic Alliance (DA) to address the vaccine shortage through legal and advocacy efforts.
- Pressuring OBP as a state-owned entity to rectify the constraints and ensure effective vaccine production.

#### **Stakeholder Actions:**

DearSA's review of public feedback to determine necessary corrective actions and increase awareness.

- SAAI's litigious journey with multiple stakeholders to address vaccine shortages affecting controlled disease spread, such as African Horse Sickness and Blue Tongue disease.
- The DA's collaboration with DearSA and other groups seeking urgent remedies for the current constraints through public pressure and awareness.

#### **Impact and Progress:**

- Public pressure took positive effect, resulting in OBP manufacturing approximately 25,000 African Horse Sickness Vaccines announced on 31 May 2023.
- Continued efforts required to address the outstanding vaccination needs and ensure a comprehensive vaccine supply.
- Increased awareness among farmers, horse owners, and livestock owners about the consequences of the vaccine shortage on legislative compliance and animal welfare.

#### **Challenges and Future Steps:**

- OBP's ability to meet the ongoing demand for various vaccinations.
- The need for sustained pressure on OBP and other relevant stakeholders to prioritize vaccine production.
- Continued collaboration between DearSA, SAAI, the DA, and other stakeholders to ensure long-term solutions and prevent future shortages.


1) Are you aware of the current animal vaccine shortages?








# 2) What is your top concern?



# **COMMENTS**

The participants are encouraged to provide comments to justify their selection to help shape the policy amendment.

Of the <u>Yes comments</u>, the submissions have outlined the following trends as a product of the main issues in these vaccine shortages:

- i) No management of controlled diseases in livestock (Blue Tongue, Foot and Mouth Disease, Slenkdal fever)
- ii) Prohibiting movement / transportation of animals
- iii) African Horse Sickness cases are growing and affecting the equine sector in a personal capacity and on a commercial level.

The public are concerned that the lack of availability of the vaccines started more than 5 years ago and has been on a steady decline, without any other mechanisms being considered by government to allow alternate vaccine suppliers. This shortage is forcing horse and livestock owners to contravene laws pertaining to Animal Welfare where certain vaccination programmes are mandatory. Without the supplies from OBP, this compliance cannot be obtained. Government cannot provide any guarantees that controlled diseases will be managed, increasing the risk of a disease outbreak. Compromised immune systems and large numbers of disease spread amongst citizens could astronomically crash the health system and result in severe food shortages.

The element of animal welfare has also been repeatedly mentioned, horses are dying painfully and tragically from not being able to receive the necessary vaccinations against African Horse Sickness (AHS) despite horse owners'

best efforts. The AHS vaccine strain is also unique to other regions as we host a variant stronger. Therefore, even if the availability to import this vaccine was granted, this may not serve to address the correct virus strains.

# Suggestions from the Yes I do comments, include:

All of the above	<ol> <li>"Inability of the entire A N C group to govern any working facility or town! As they want big pay but can't keep a good governance of South Africa!"</li> <li>"The collapse and total failure of all state monopolies illustrates the need to open up all key manufacturing requirements to the private sector."</li> <li>"We were unable to get Blue Tongue Vaccine for our 200+ sheep in 2022 and struggled to get it in 2021 as well. This is a concern for all vaccines, the costs are getting too much for farmers to afford as well which will affect the consumer at the end of the day too."</li> <li>"This shortage will affect the whole of South Africa. It is easy to blame everything now on Eskom but as usual, nothing was done to prevent the shortages. Competent people should be appointed to do the work."</li> <li>"OP's machine to make in particular, the African Horse Sickness vaccine, broke down and they needed parts from other countries to fix it. In the meantime, plenty of people couldn't get their horses vaccinated. We have had an incredibly tough AHS season this year with all the rain, I can't say if all the horses died would have survived had they had the vaccine, but we will never know."</li> <li>"Any farming, be it livestock or vegetables depends on electricity and on keeping the product line healthy. No farming, no food, no supply chain. ESKOM should be paying OBP from the R254billion just been granted to them. They need a solar plant."</li> <li>"I have 4 cats and if the vaccine for farm animals is in short supply, I am sure we can expect that vaccines for pets will also be affected in the furture. It is time that the ANC get their act together or give the country over to people that know what to do!!!!!"</li> </ol>

It is now for at least the last 5 years."</li> <li>"Allow private sector to manufacture vaccines."</li> </ol>
Inability to get an alternate vaccine product approved locally	<ol> <li>"All the livestock walking in the urban areas, should become part of the food chain. These animals can be a big contributor to the crises in this sector. Government should realize the importance of healthy meat products for a healthy nation. Health first and money last."</li> <li>"It is absurd that alternative vaccines and Vor imported vaccines are not approved locally, which would prevent livestock losses. Is the government completely oblivious, or are they purposely contributing to agricultural regression?"</li> <li>"If OBP cannot do its job, licensing approval for those who can, must be allowed. How can this country twiddle its thumbs over a critical food security issue? That's besides the utter cruelty of allowing thousands of animals to suffer hideous deaths needlessly. It is unacceptable."</li> <li>"Ahs vaccine is outdated and not available. When it is available is certainly does not work. Look at the massive outbreak. I have personally lost 5 horses to ahs this year."</li> <li>"AHS is pretty much fatal yet we're unable to vaccinate to even attempt to protect our animals. Also, it's compulsory to vaccinate, so the government is making it impossible for people to be compliant with its own legislation."</li> </ol>
Shortage of vaccines for horses	<ol> <li>"There are a few reasons why the lack of and inability to get these crucial vaccines for our animals is of such great concern. First of all, their health is at risk in certain seasons and at highrisk times of the year. Secondly, for competitive purposes we may not enter our horses due to them not having had their vaccines for a lengthened period of time. Ondersterpoort cannot have the monopoly anymore. We need to let other pharmaceutical companies produce these required vaccines to ensure a shortage doesn't happen again and so that EVERYONE is able to get stock of vaccines for their animals."</li> <li>"The government should be made to pay for every horse that dies. This is a tragic situation caused by incompetence and general uncaring attitude of government towards animals. As usual its money &amp; they don't want any other pharma company to come up with alternatives where they would lose out on income."</li> <li>"I live in a disease-free area; without vaccines we can't move our animals."</li> </ol>

	<ol> <li>"African horse sickness kills thousands of horses every year and now where it an annual vaccine it is poised to kill tens of thousands thanks to the ANC's total inability to foresee the problems associated with Eskoms rolling blackouts. We need to change our government and get someone else to get us out of this mess and we need to allow non-state-owned entities to provide us desperate public with alternative vaccines for our animals."</li> <li>"We lost 4 horses to African Horse Sickness due to shortages/non supply."</li> <li>"Non availability of the horse sickness vaccine. About nothing is as important as having the correct vaccine overnight. I have experienced losing half a sheep herd also 2 bulls in one night."</li> <li>"Treatment plan and medicine for horses with AHS."</li> </ol>
Effectiveness of the vaccines	<ol> <li>"Ahs is deadly and horses need to be vaccinated."</li> <li>"Horses are dying due to the fact that the vaccine has never been upgraded even although the Ahs virus has mutated it's ineffective."</li> <li>"Besides poor availability, I question the effectiveness of the vaccine along with asking why are there no other vaccine strains available?"</li> <li>"I do feel that this is a possible manipulation of the situation to encourage fast tracking of alternate vaccines (locally made and imported) without proper long-term studies which is most definitely not a good idea, as these are going to be ingested by millions of people without knowing the effects."</li> </ol>

Of the <u>Not Fully comments</u>, the participants indicated a blanket trend of distrust and broken-down faith in the long-term sustainability and growth of any state-owned entity, automatically including OBP. In addition, some of the suggestions received, indicated that OBP should be privatised to increase its efficiency back to where it was. Further to this, the public have advised that the importation of vaccines should only be visited as a last resort if local manufacturers are unable to fulfil the required vaccine quotas to ensure that the food security is managed.

All of the above	<ol> <li>"The Ondersterpoort department of vaccines is a government department, say no more."</li> <li>"I know of horses that have died causing pain and suffering to owners. As well as suffering to the horses."</li> <li>"The government is largely disconnected from real business and real farmers and the challenges faced by these real workers and employers; they should try to do something right and honest (for a change) and help those in the workforce who grown food and generate taxes."</li> <li>"The effect on food supply chain could be devastating!!!"</li> </ol>

Other	<ol> <li>"The corruption is so systemic in SA. The shortage of vaccines is being blamed on Eskom primarily, but load shedding has been around for 15 years. This is just an excuse to cover over corruption in another state-owned entity. The failure will lead to sourcing alternatives which have lucrative kickbacks for government agencies."</li> <li>"I am against any form of vaccinesthey are poison. Never really solve any problem."</li> <li>"This is a huge problem. The farmer is the lifeblood of South Africa, or any country. Our farmers have in the past been well taken care of by the Government in times of floods, droughts, animals' sickness and even bad financial times. The Government then, knew the place of the farmer and supported them. The Government now, has horrifically adopted the world system thinking and implementing it. Animals, in addition to not receiving the vaccines they need to keep them immune and healthy, are ALSO receiving injections that are cruelly affective to them AND to the consumer. Of the <u>No I do not comments</u>, the respondents unanimously indicated that the vaccine programme of the animals is in a fragile state caused by OBP's poor management and were not aware of this present situation. OBP is known for being a well-kept organisation, and that the load shedding cannot be utilised as a mask to the problem. It has been identified by the public that the corruption and lack of support by the government has exponentially strained the current livestock industry directly affecting the food sources for the nation.

A small minority of the received comments indicated that meat should not be consumed at all.
